This 30-day extension will also be available to any trustee organization not listed above, provided that such organization: (1) identifies themselves and designate a representative by close of business February 25, 2010 and (2) submit of a list of all sales noticed for the 575 Administration Drive location by no later than the close of business on Friday, March 5, 2010.

To ameliorate congestion in the main lobby, we would like to request that you use your best efforts, starting March 1, 2010, to conduct all auctions on the northern side of the building. Signs directing individuals to the northern side of the building will be posted.

It is our hope that a new location can be selected by no later than March 5, 2010, so that all notices issued on or after March 6, 2010 can be made for this new location.
