EMERGENCY ORDER REGARDING THE DISTRICT COURT OF THE FIRST CIRCUIT'S  
ADDITIONAL RESPONSE TO THE COVID-19 OUTBREAK

This matter comes before the Court in light of the public health emergency in the State of Hawai'i. Pursuant to Chief Justice Mark E. Recktenwald's Order regarding the coronavirus (COVID-19) filed in SCMF No. 20-0000152 on March 16, 2020, and Chief Judge R. Mark Browning's Emergency Order #5 Regarding District Court of the First Circuit filed in SP No. 1CSP-20-0000082 on March 16, 2020, and with authority as Deputy Chief Judge of the District Court of the First Circuit, State of Hawai'i, the Court hereby orders the following:

1. The Kāne'ohe District Court, the 'Ewa District Court, the Wahiawā District Court, and the Wai'anae District Court shall be closed from March 23, 2020, through April 30, 2020.

2. The Traffic Violations Bureau and Legal Documents Branch on the second and third floors of the Honolulu District Court shall be closed to the public from March 23, 2020, through April 30, 2020. Petitions for Temporary Restraining Orders may be filed at the Information Booth, located on the plaza of the Honolulu District Court, outside the entrance to the courthouse. Filings in all other civil cases shall be filed electronically. In the event a party is unable to file a document electronically, the document may be filed at the Information Booth.

3. Beginning on March 23, 2020, the essential court proceedings referenced in SP No. 1CSP-20-0000082, Emergency Order #5 Regarding District Court of the First Circuit, shall be consolidated into four (4) court units. Four (4) courtrooms in the Honolulu District Court will be utilized for these proceedings.


4. For TRO cases filed between March 23, 2020, and April 30, 2020, no more than five (5) cases shall be set during any court session.

5. For cases involving defendants currently in the custody of the Honolulu Police Department, the Oahu Community Correctional Center, and/or the Hawai'i State Hospital, video conferencing shall be used to the extent possible.

6. While court proceedings remain open to the public, judges and court staff shall encourage persons present in the courtroom to be mindful of the need for social distancing.

IT IS SO ORDERED.

ORDER EXTENDING DEADLINES  
IN THE CIRCUIT, DISTRICT AND FAMILY COURTS  
(By: Recktenwald, C.J.)

Upon consideration of the state of emergency proclaimed by Governor David Y. Ige on March 5, 2020, and in accordance with Article VI, sections 6 and 7 of the Hawai'i State Constitution and Hawai'i Revised Statutes sections 601-1.5 and 601-2,

IT IS HEREBY ORDERED that all deadlines, time schedules, and filing requirements imposed by statutes, rules, or court orders, in all civil, criminal, and administrative matters in the circuit, district and family courts in the State of Hawai'i that expire between March 23, 2020 through and including April 3, 2020, are extended to April 6, 2020.

This order may be modified or extended as necessary.

**MARCH 23, 2020 TEMPORARY GENERAL ORDER REGARDING  
DISTRICT OF HAWAII RESPONSE TO COVID-19 EMERGENCY**

In response to the COVID-19 public emergency, the Centers for Disease Control and Prevention has issued guidelines recommending against gatherings of fifty or more persons, effective March 15, 2020. On March 16, 2020, President Trump cautioned that gatherings should be limited to ten persons or fewer. Further, the World Health Organization declared COVID-19 a global pandemic on March 11, 2020; President Trump declared the outbreak to constitute a national emergency on March 13, 2020; Hawaii State Governor David Ige declared a state of emergency on March 4, 2020; and Honolulu Mayor Kirk Caldwell entered an emergency “Stay at Home/Work from Home” order on March 22, 2020.

The Court has weighed the right of the public and media to access to the court against the need to protect the safety of the public, including the health of all those entering and working in the court. Given the compelling need for the court to protect the health and safety of the public and court employees, the following restrictions will be in place for the United States District Court for the District of Hawaii until May 3, 2020, unless extended or otherwise ordered by the court:

**Restrictions on Court Proceedings:**

- All civil and criminal trials scheduled to commence between March 17, 2020 and May 3, 2020 before any district or magistrate judge are CONTINUED;

- With respect to criminal trials, each presiding judge assigned to any trial scheduled to commence between March 17, 2020 and May 3, 2020 will make appropriate findings and enter an order tolling time under the Speedy Trial Act; that is, although all judges agree that no trials can be held before May 3, 2020, each presiding judge will make the individual findings required by the Speedy Trial Act;
- All civil hearings, including settlement conferences, scheduled between March 17, 2020 and May 3, 2020 will either be conducted telephonically or will be taken off the court's calendar pursuant to Local Rule 7.1. Each presiding district or magistrate judge retains the discretion to determine that a hearing in any particular civil matter is essential, and thus require that the parties appear in court;
- Non-essential criminal matters will be continued until a date after May 3, 2020. For example, most change of plea hearings, sentencing hearings and motions to suppress can be continued. Again, a presiding judge retains the discretion to determine to proceed with any particular criminal matter. Counsel are requested to confer regarding these dates, and stipulate to appropriate continuances under the Speedy Trial Act, if possible;
- The court will continue to conduct initial appearances, arraignments, detention hearings, and other time-sensitive matters typically handled by magistrate judges;
- The court will implement prudent measures to reduce the number of people and level of interaction at preliminary criminal matters, including, to the extent possible, the use of a fourth-floor courtroom to help with social distancing and permitting and/or requiring attorneys and other personnel to participate telephonically;
- Filings will continue to be processed in civil and criminal cases via the CM-ECF electronic system and by mail. Paper documents will be received in the drop box located outside the courthouse. Payments will be processed via credit card utilizing Pay.gov. Payments by check or money order will be accepted by mail or the courthouse drop box. Cash payments will NOT be accepted during this period of exigent circumstances; and

- Until further notice, in both civil and criminal matters, no courtesy copies of filings are to be provided to chambers unless specifically ordered by a presiding judge.

### **Restrictions on Entry to the Courthouse:**

Effective immediately, the United States District Court for the District of Hawaii is closed to the public until May 3, 2020, with the following accommodations to permit public and media access to court proceedings that would otherwise be open to the public:

First, civil and criminal hearings will be conducted on a toll-free teleconference line, and that teleconference line will be available to members of the public and the media, to the extent practicable. Dial-in information will be available on each case's individual docket on PACER, and further instructions can be found on the court's website. Members of the public and media are strictly prohibited from recording or broadcasting any hearing, in whole or in part, in any fashion. Further restrictions are set forth on the court's website, and may change from time to time.

Second, any member of the public or media may request access to the courthouse to attend a particular in-court hearing. Seating will be limited—courtrooms will only be able to accommodate a limited number of people in order to maintain social distancing. Counsel for defendants in a criminal case may also request to be given access to the courthouse for a particular in-court hearing. The presiding judge has the final, discretionary authority to grant or deny any specific request to appear in person, and to limit the number of persons entering the courthouse. The United States Marshals Service may also deny entry to any person considered a risk to carry the COVID-19 virus. Instructions on how to request permission to enter the courthouse can be found on the court's website. Further, anyone requesting entry to the courthouse are reminded of the City and County of Honolulu's March 22, 2020 "Stay at Home/Work From Home" Order.

This Temporary General Order supersedes the March 17, 2020 “Temporary General Order Regarding District of Hawaii Response to COVID-19 Emergency.”
